August 1, 2023, New York, NY -- Vesttoo will lay off 75% of its staff and will shutter some Asia offices following allegations that fraudulent letters of credit (LOC) were issued in the name of third-party banks as part of transactions arranged via its platform, according to a recent report. Vesttoo, which has around 200 staff, will close its Tokyo, Hong Kong, and Seoul offices, Reuters reported. It will maintain a presence in Tel Aviv, London, Bermuda, New York, and Dubai, according to the report ...


